This matter having come before the Court on Plaintiff Las Vegas Review Journal, Inc.'s Ex Parte Application for an Emergency Temporary Restraining Order and Preliminary Injunction Hearing, and good cause appearing therefor, the Court finds that this is a proper instance for the issuance of a Temporary Restraining Order and that unless

1 restrained and enjoined by Order of this Court, immediate and irreparable injury and
2 damage will result to the Las Vegas Review Journal Inc. The Court finds that the Las
3 Vegas Review Journal Inc. has complied with NRCP 65 and met its burden herein.
4 Therefore:

5 **IT IS HEREBY ORDERED** that a temporary restraining order is issued, enjoining
6 parties Las Vegas Metropolitan Police Department, Clark County District Attorney's
7 Office, and Clark County Public Defender's Office from: inspecting or searching any
8 device seized from the residence of Jeff German or accessing or viewing, or attempting to
9 access or view, any information or materials contained on any device.

10 **IT IS FURTHER ORDERED** that this Order shall expire within fifteen (15) days
11 after entry, unless within such time the Order, for good cause shown, is extended, or unless
12 all parties consent that it may be extended for a longer period.

13 **IT IS FURTHER ORDERED** that a hearing for the Review-Journal's request for
14 a preliminary injunction is set for the 12th day of October, 2022, at 9:00 a.m.

15 **IT IS FURTHER ORDERED** that any party opposing the Motion shall file their
16 responsive pleading 2 judicial days prior to the time set for the hearing.

17 **IT IS FURTHER ORDERED** that bond is set in the amount of \$500.

18 **IT IS SO ORDERED.**
