



> Today, 12/6/2018, at approximately 1330 (b) (6), (b) (7)(C) contacted agents in the field and informed them that an individual south of the international border fence was throwing rocks over the fence. They pulled out of the area and asked agents to help provide security. When our agents arrived on scene, the individual was still in the area. According to an ATV agent, the subject through a single rock over the fence, but not at anyone or anything in particular. It landed in the dirt on the hillside. At the moment of our response, there were two individuals in Mexico taking pictures. They were fully equipped with what appeared to be professional photography equipment, to include long lenses and a tripod. The whole thing appeared staged. Due to our response, the individual did not throw any more rocks, but the photographers remained in the area. The agents only made mention of one rock thrower and one rock being thrown.
